Program Description:

This workshop will explore social learning concepts in Core Curriculum Standards, review inferential skills, and examine strategies to build understanding of intention, behavior, & effect. It will cover the importance of perspective, emotions and flexibility, as well as ways to support development of conversation.

Learner Outcomes:

Participants will:

- 1. Explain why silence is an important therapeutic tool.
- 2. Create 2 visual supports that could be used with students with whom they work and explain why they are necessary.
- 3. Define jump cuts and describe how they relate to social learning.
- 4. Support via research why using materials that move, such as a YouTube video, makes sense.
- 5. Explain why interjections are so important and how to work on them with students.
- 6. Demonstrate how to use a conversation map with a student with whom they work.
